



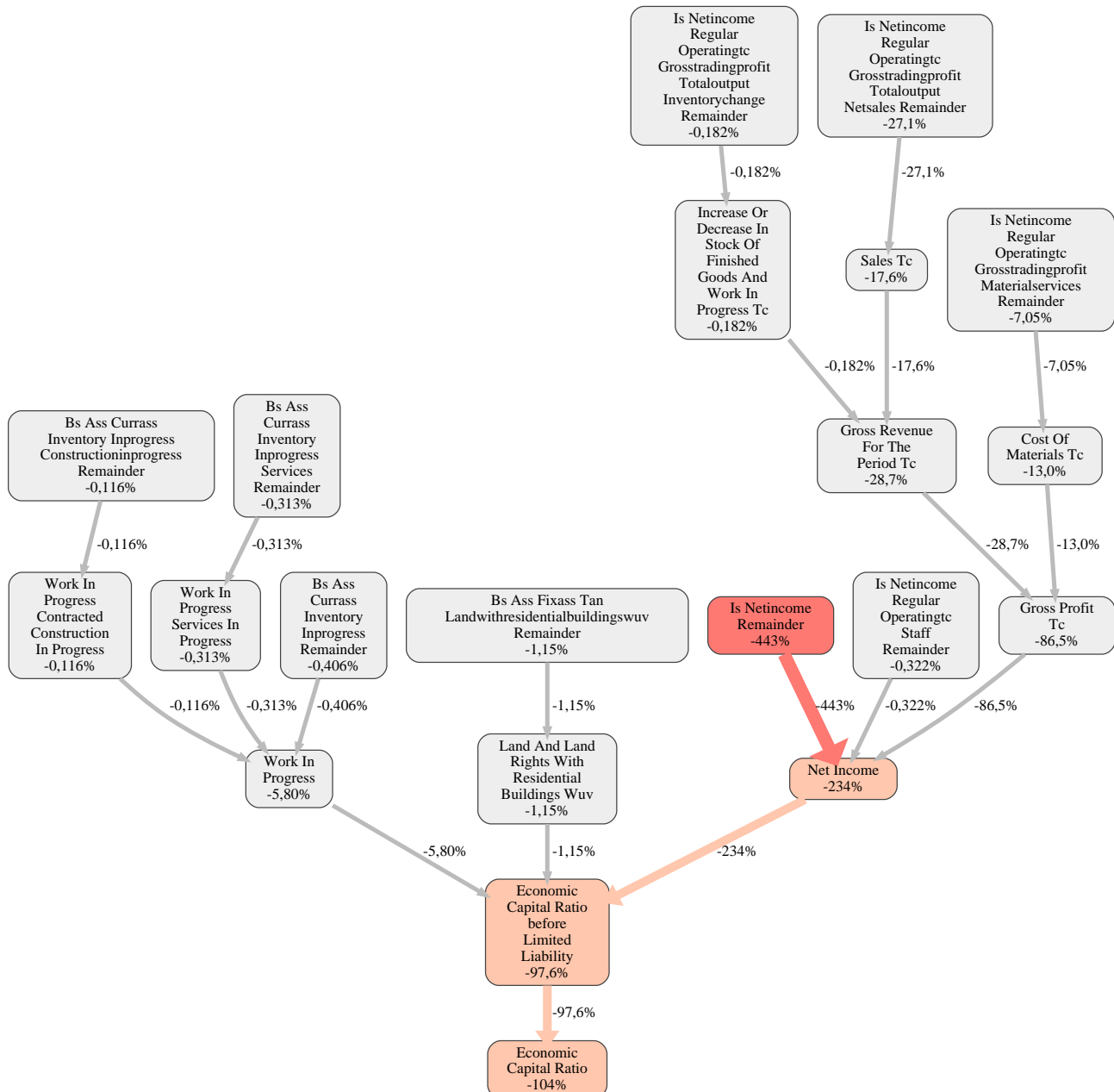

The relative strengths and weaknesses of wb Service GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of wb Service GmbH compared to the market average is the variable Personnel Expenses Tc, increasing the Economic Capital Ratio by 0,024% points. The greatest weakness of wb Service GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 443% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,024%, being 104% points below the market average of 104%.
