





The greatest strength of HIW Hoch und Ingenieurbau Wilsdruff GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Inventorychange Remainder, increasing the Economic Capital Ratio by 101% points. The greatest weakness of HIW Hoch und Ingenieurbau Wilsdruff GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 1.273% points.

The company's Economic Capital Ratio, given in the ranking table, is 101%, being 3,1% points below the market average of 104%.
