



The relative strengths and weaknesses of Lindner Fassaden GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lindner Fassaden GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 187% points. The greatest weakness of Lindner Fassaden GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 342% points.

The company's Economic Capital Ratio, given in the ranking table, is 188%, being 84% points above the market average of 104%.
