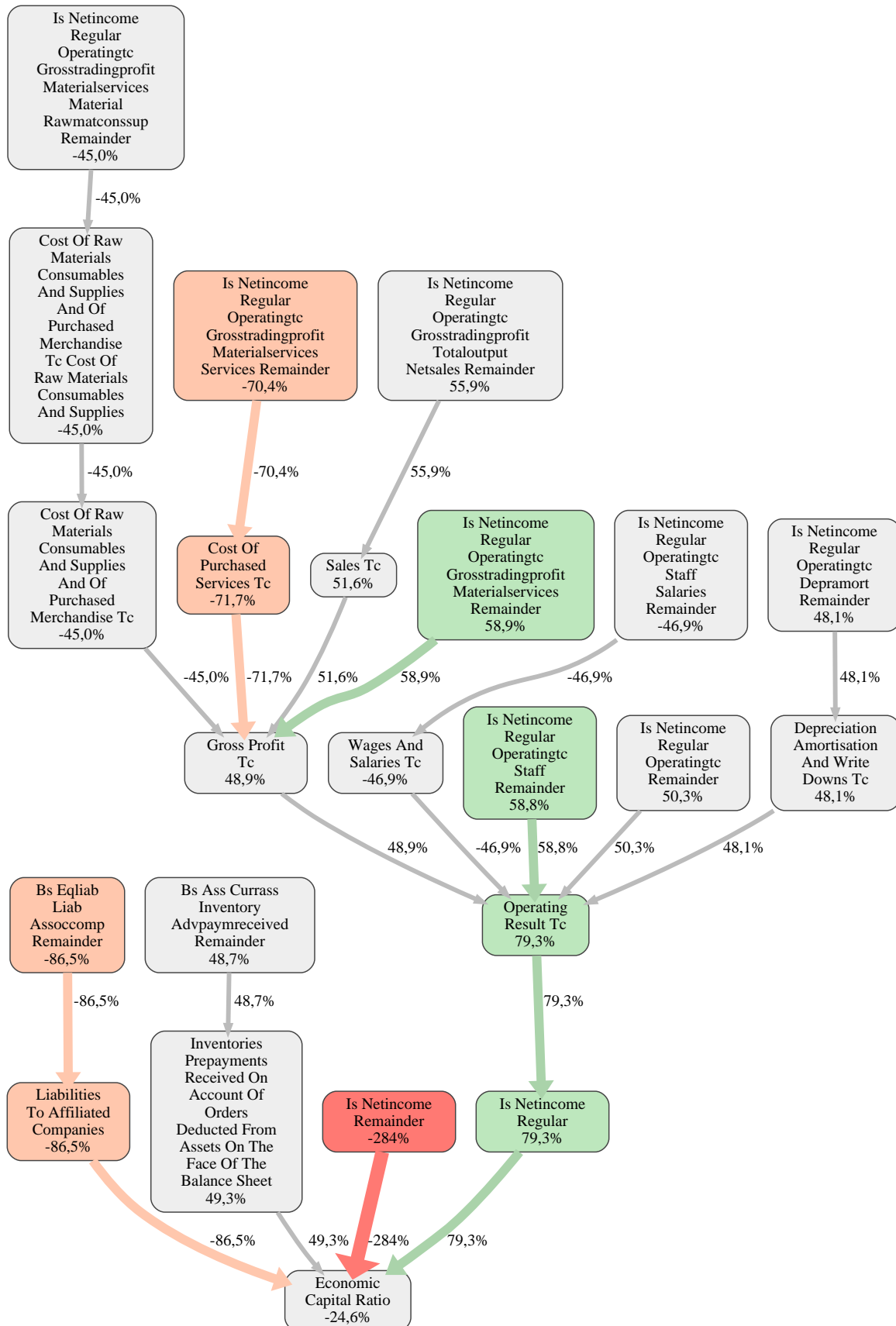

The relative strengths and weaknesses of Implenia Schalungsbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Implenia Schalungsbau GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Implenia Schalungsbau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 284% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 25% points below the market average of 104%.
