



The relative strengths and weaknesses of Let Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Let Bau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 193% points. The greatest weakness of Let Bau GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 324% points.

The company's Economic Capital Ratio, given in the ranking table, is 196%, being 92% points above the market average of 104%.
