

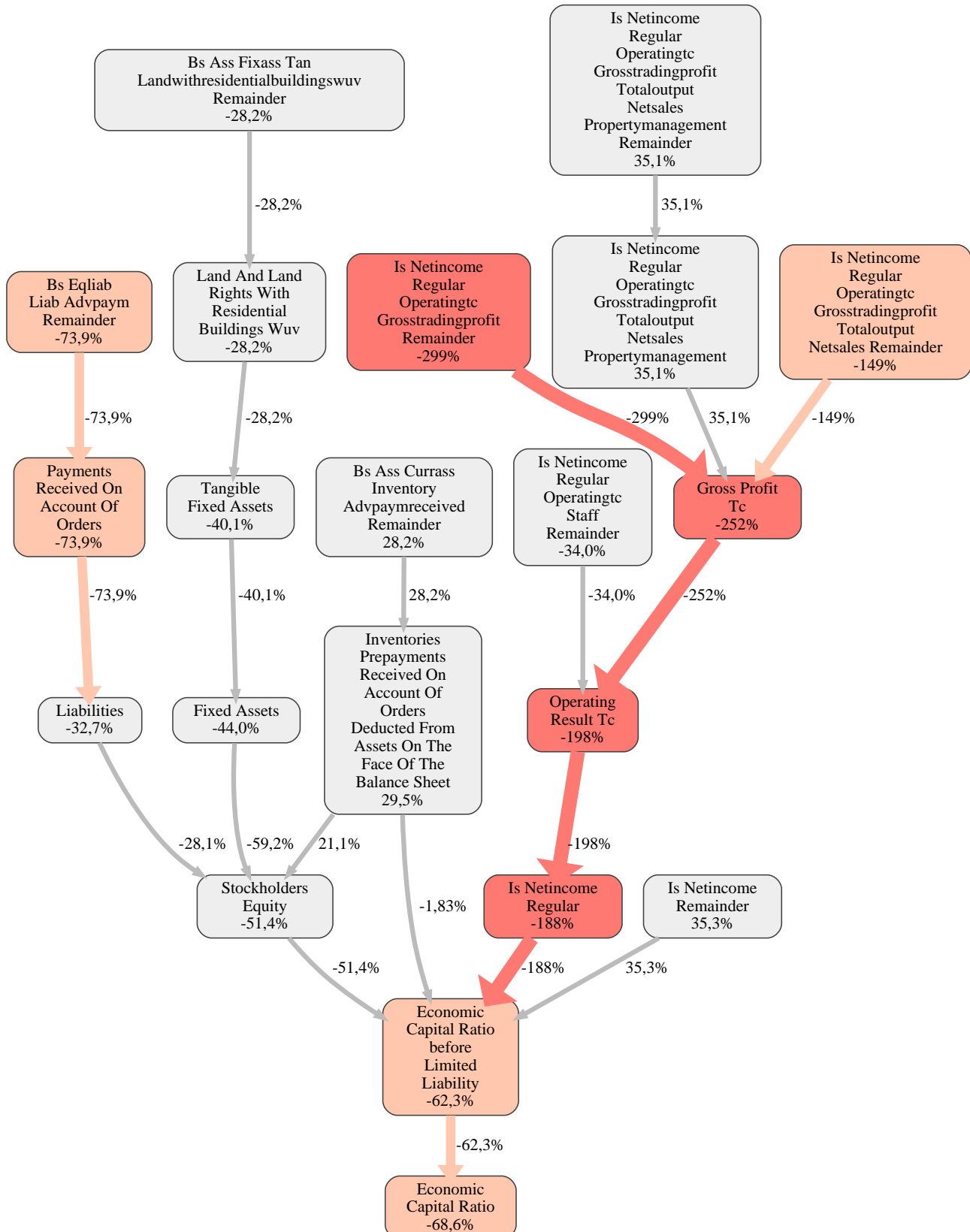

The relative strengths and weaknesses of BBS Bau und Betriebsservice GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BBS Bau und Betriebsservice GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 35% points. The greatest weakness of BBS Bau und Betriebsservice GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 299% points.

The company's Economic Capital Ratio, given in the ranking table, is 35%, being 69% points below the market average of 104%.
