



The relative strengths and weaknesses of NAP Immo GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of NAP Immo GmbH compared to the market average is the variable Bs Ass Fixass Tan Remainder, increasing the Economic Capital Ratio by 57% points. The greatest weakness of NAP Immo GmbH is the variable Bs Eqliab Liab Remainder, reducing the Economic Capital Ratio by 192% points.

The company's Economic Capital Ratio, given in the ranking table, is 66%, being 37% points below the market average of 104%.
