

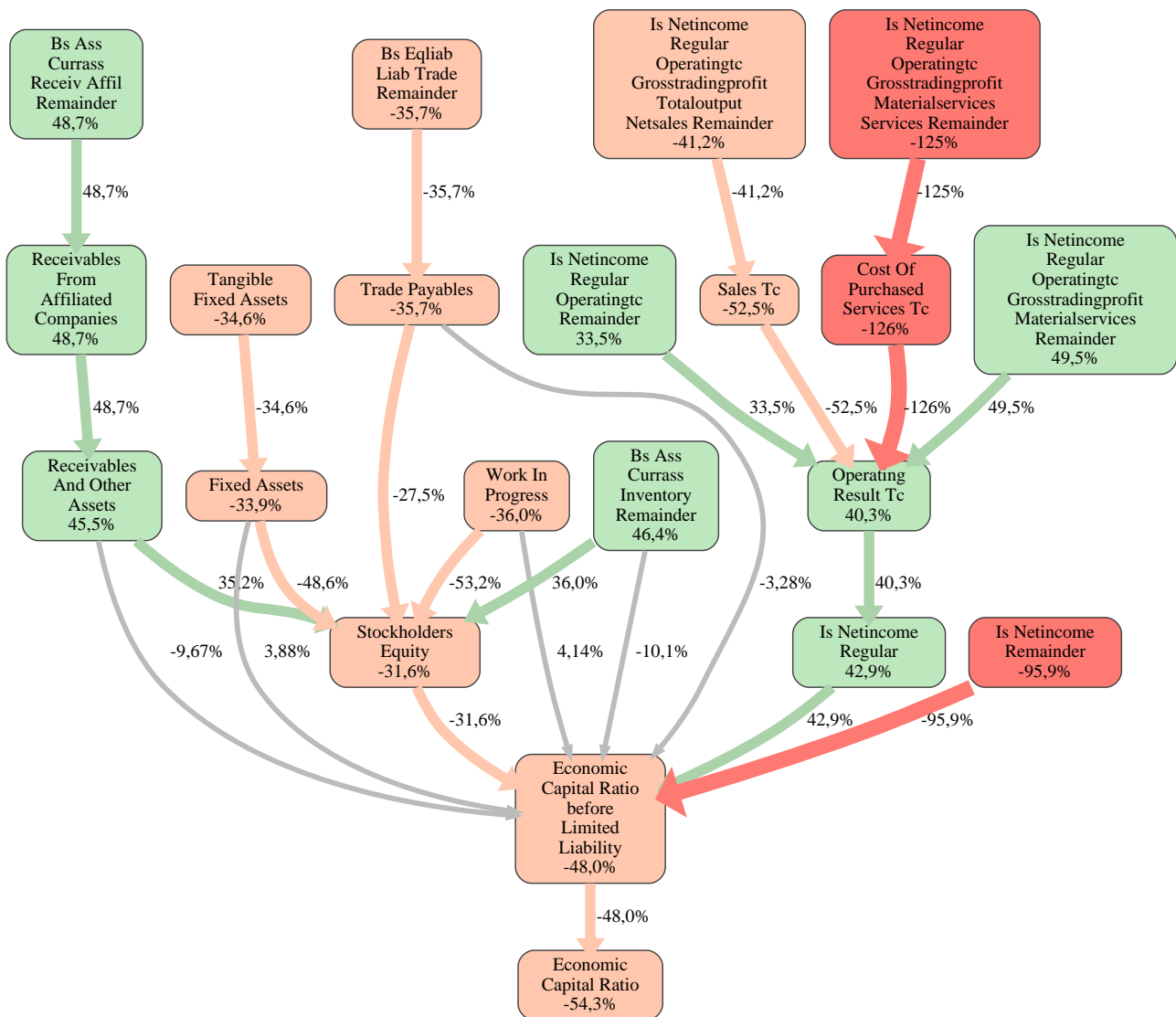

The relative strengths and weaknesses of Implenla Hochbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Implenla Hochbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 50% points. The greatest weakness of Implenla Hochbau GmbH is the variable Cost Of Purchased Services Tc, reducing the Economic Capital Ratio by 126% points.

The company's Economic Capital Ratio, given in the ranking table, is 50%, being 54% points below the market average of 104%.
