

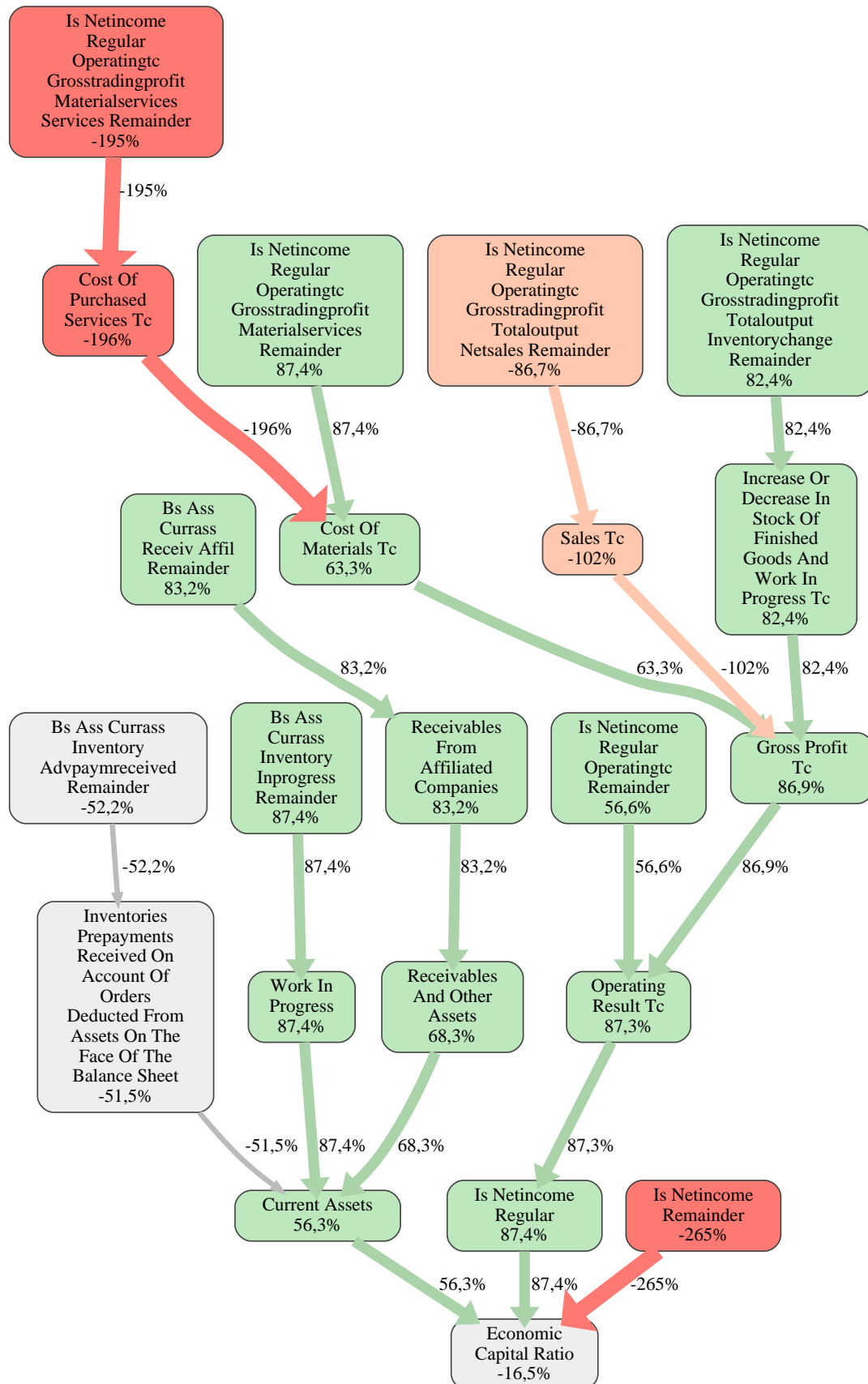

The relative strengths and weaknesses of Porr Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Porr Industriebau GmbH compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 87% points. The greatest weakness of Porr Industriebau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 265% points.

The company's Economic Capital Ratio, given in the ranking table, is 87%, being 16% points below the market average of 104%.
