

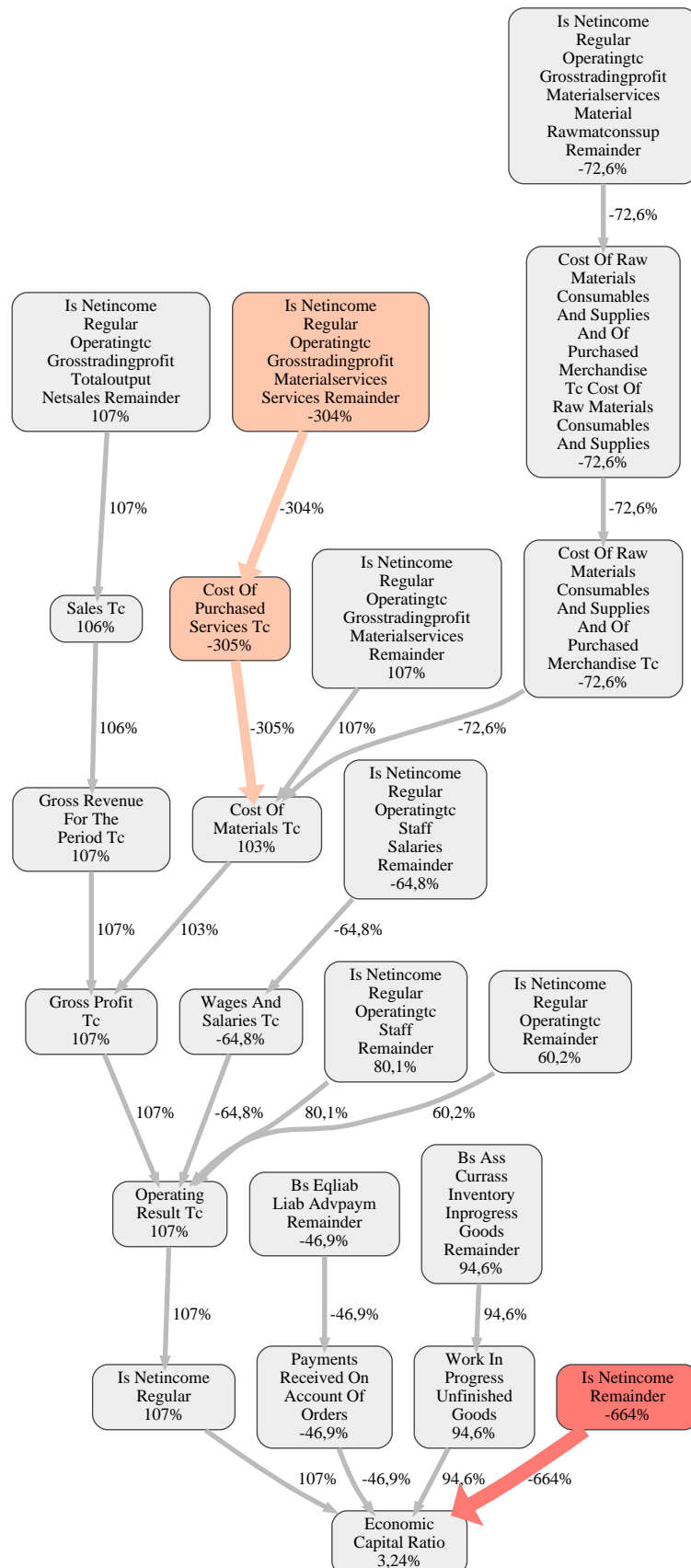

The relative strengths and weaknesses of Markgraf Familien GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 107% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 664% points.

The company's Economic Capital Ratio, given in the ranking table, is 107%, being 3,2% points above the market average of 104%.
