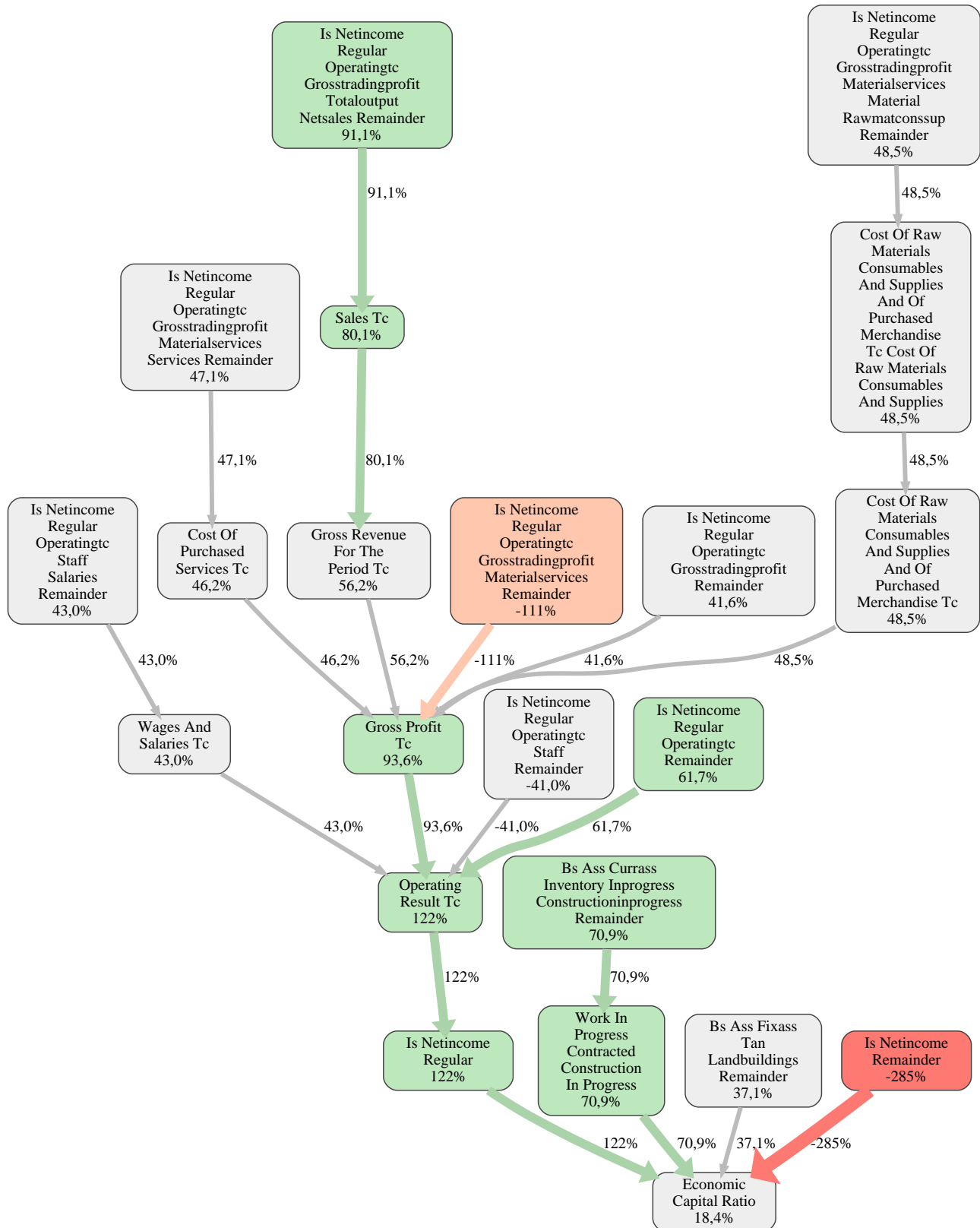

The greatest strength of Kurt Motz Holding GmbH Co KG Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 122% points. The greatest weakness of Kurt Motz Holding GmbH Co KG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 285% points.

The company's Economic Capital Ratio, given in the ranking table, is 122%, being 18% points above the market average of 104%.
