



The relative strengths and weaknesses of Bremer AG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bremer AG Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 185% points. The greatest weakness of Bremer AG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 985% points.

The company's Economic Capital Ratio, given in the ranking table, is 185%, being 81% points above the market average of 104%.
