



The relative strengths and weaknesses of Kleusberg Holding GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kleusberg Holding GmbH Co KG Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 160% points. The greatest weakness of Kleusberg Holding GmbH Co KG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 294% points.

The company's Economic Capital Ratio, given in the ranking table, is 162%, being 59% points above the market average of 104%.
