



The relative strengths and weaknesses of Michael Klebl GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Michael Klebl GmbH Co KG Konzern compared to the market average is the variable Bs Ass Currass Inventory Remainder, increasing the Economic Capital Ratio by 153% points. The greatest weakness of Michael Klebl GmbH Co KG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 556% points.

The company's Economic Capital Ratio, given in the ranking table, is 153%, being 49% points above the market average of 104%.
