



The relative strengths and weaknesses of PORR Oevermann GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of PORR Oevermann GmbH Konzern compared to the market average is the variable Bs Ass Currass Inventory Remainder, increasing the Economic Capital Ratio by 96% points. The greatest weakness of PORR Oevermann GmbH Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 474% points.

The company's Economic Capital Ratio, given in the ranking table, is 96%, being 7,8% points below the market average of 104%.
