



The relative strengths and weaknesses of Wohnbaugruppe Augsburg Leben GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbaugruppe Augsburg Leben GmbH Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 69% points. The greatest weakness of Wohnbaugruppe Augsburg Leben GmbH Konzern is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 288% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 35% points below the market average of 104%.
