



The relative strengths and weaknesses of Joachim Nessler Geschäftsführungsgesellschaft mbh Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Joachim Nessler Geschäftsführungsgesellschaft mbh Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Services Remainder, increasing the Economic Capital Ratio by 86% points. The greatest weakness of Joachim Nessler Geschäftsführungsgesellschaft mbh Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 404% points.

The company's Economic Capital Ratio, given in the ranking table, is 86%, being 18% points below the market average of 104%.
