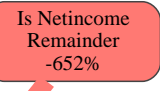

The greatest strength of Himmel u Papesch Bauunternehmung GmbH Co KG Konzern compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 78% points. The greatest weakness of Himmel u Papesch Bauunternehmung GmbH Co KG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 652% points.

The company's Economic Capital Ratio, given in the ranking table, is 78%, being 26% points below the market average of 104%.
