



The relative strengths and weaknesses of Howoge Wohnungsbaugesellschaft mit Beschränkter Haftung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Howoge Wohnungsbaugesellschaft mit Beschränkter Haftung Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 200% points. The greatest weakness of Howoge Wohnungsbaugesellschaft mit Beschränkter Haftung Konzern is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 298% points.

The company's Economic Capital Ratio, given in the ranking table, is 235%, being 131% points above the market average of 104%.
