



The relative strengths and weaknesses of Rensch GmbH Co Grundstücksverwaltung KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rensch GmbH Co Grundstücksverwaltung KG Konzern compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 114% points. The greatest weakness of Rensch GmbH Co Grundstücksverwaltung KG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 801% points.

The company's Economic Capital Ratio, given in the ranking table, is 114%, being 9,8% points above the market average of 104%.
