



The relative strengths and weaknesses of Adam Hörnig Baugesellschaft mbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Adam Hörnig Baugesellschaft mbH Co KG Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Adam Hörnig Baugesellschaft mbH Co KG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 264% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 25% points below the market average of 104%.
