



The relative strengths and weaknesses of Glass GmbH Bauunternehmung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Glass GmbH Bauunternehmung Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Remainder, increasing the Economic Capital Ratio by 152% points. The greatest weakness of Glass GmbH Bauunternehmung Konzern is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 697% points.

The company's Economic Capital Ratio, given in the ranking table, is 152%, being 48% points above the market average of 104%.
