



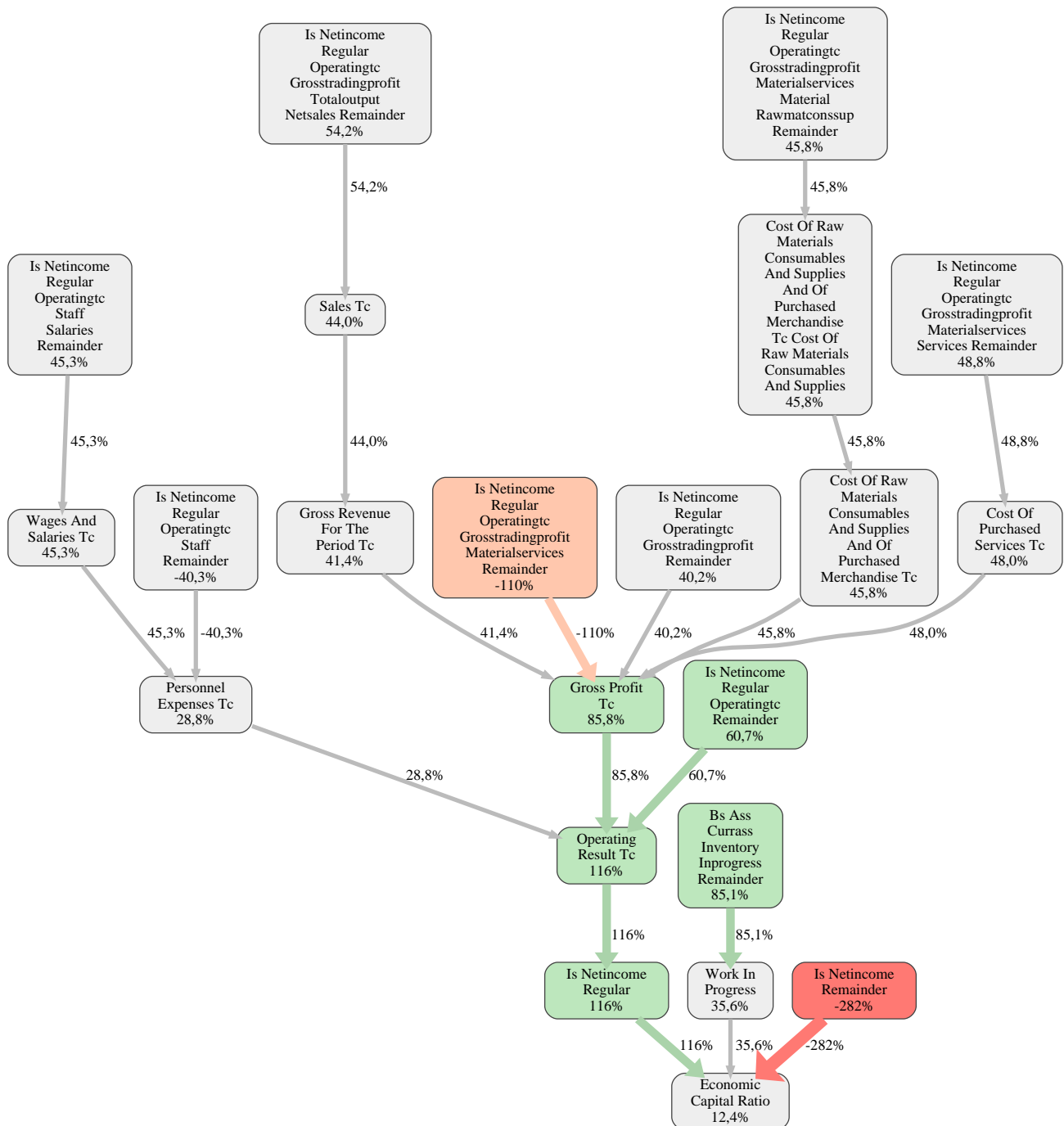

The greatest strength of Bickhardt Bau SE Vormalis Bickhardt Bau Aktiengesellschaft Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 116% points. The greatest weakness of Bickhardt Bau SE Vormalis Bickhardt Bau Aktiengesellschaft Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 282% points.

The company's Economic Capital Ratio, given in the ranking table, is 116%, being 12% points above the market average of 104%.
