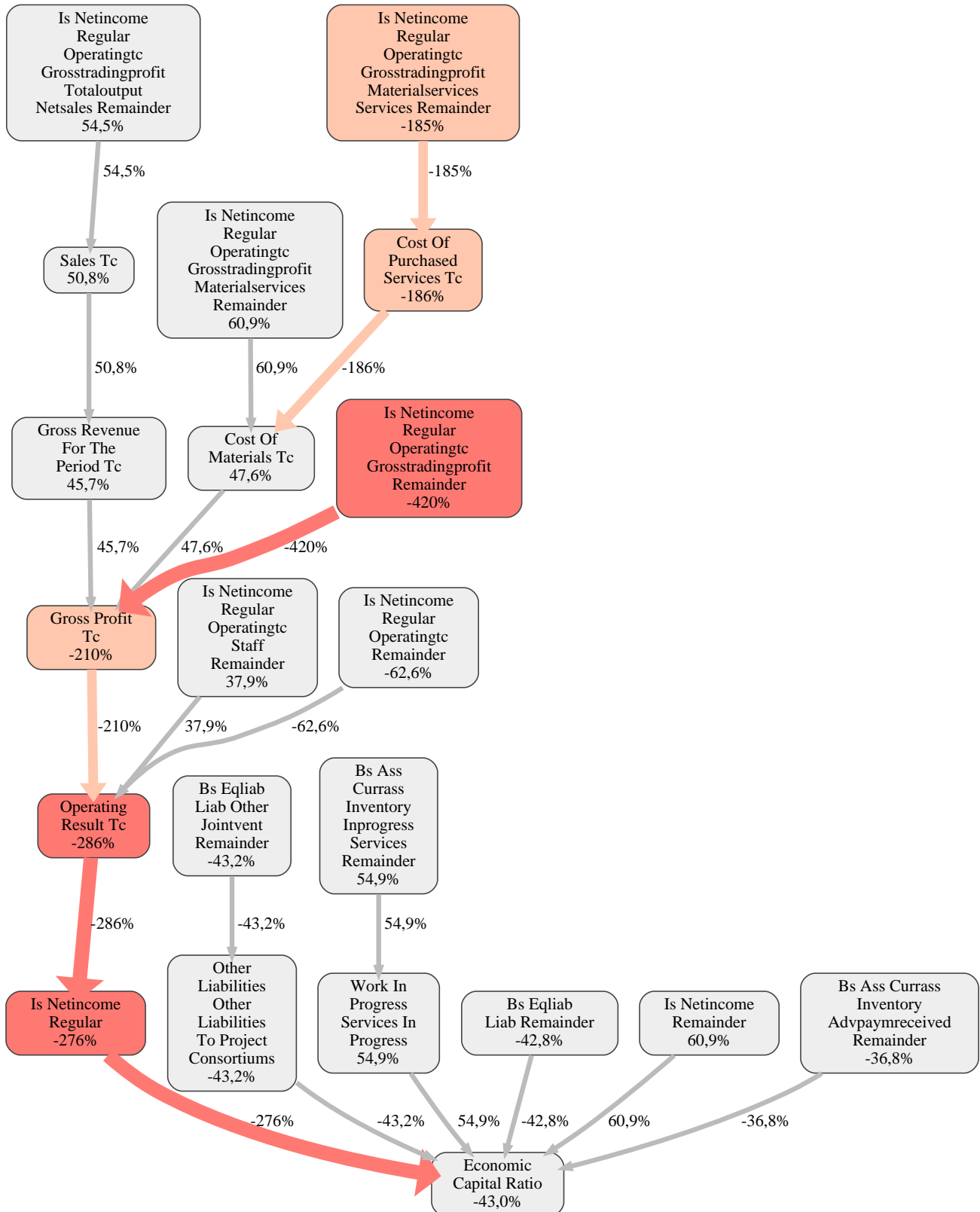

The greatest strength of Mauss Bau GmbH Co KG Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 61% points. The greatest weakness of Mauss Bau GmbH Co KG Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 420% points.

The company's Economic Capital Ratio, given in the ranking table, is 61%, being 43% points below the market average of 104%.
