



The relative strengths and weaknesses of MBN GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MBN GmbH Konzern compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 169% points. The greatest weakness of MBN GmbH Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 955% points.

The company's Economic Capital Ratio, given in the ranking table, is 169%, being 65% points above the market average of 104%.
