



The relative strengths and weaknesses of Josef Meier GmbH Co KG Hoch und Tiefbau Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Meier GmbH Co KG Hoch und Tiefbau Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Remainder, increasing the Economic Capital Ratio by 52% points. The greatest weakness of Josef Meier GmbH Co KG Hoch und Tiefbau Konzern is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 111% points.

The company's Economic Capital Ratio, given in the ranking table, is 82%, being 22% points below the market average of 104%.
