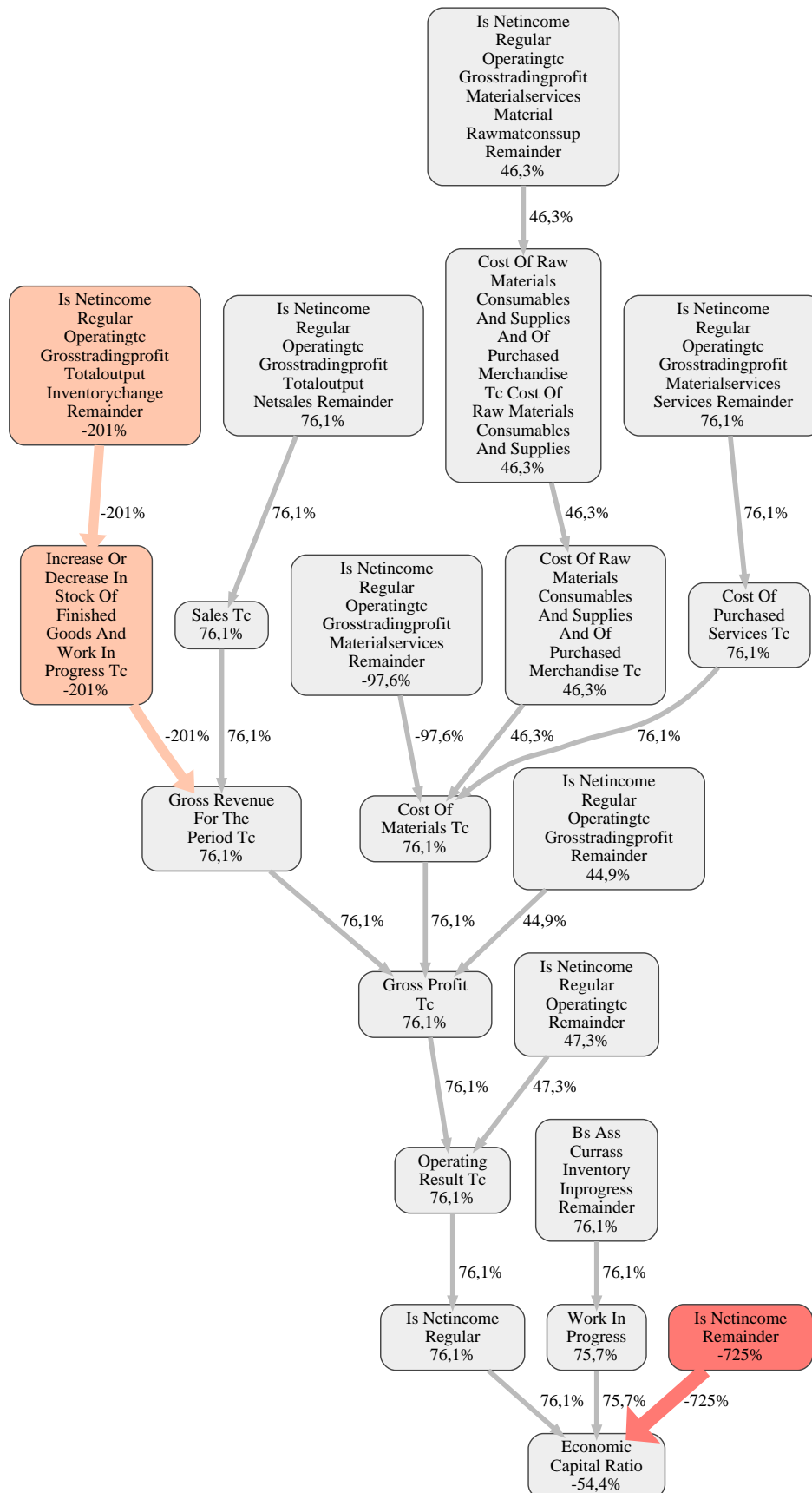

The greatest strength of BMS Industriebau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 76% points. The greatest weakness of BMS Industriebau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 725% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 54% points below the market average of 130%.
