The greatest strength of Ortwin Goldbeck Holding SE compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Ortwin Goldbeck Holding SE is the variable Operating Result Tc, reducing the Economic Capital Ratio by 310% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 45% points below the market average of 130%.
