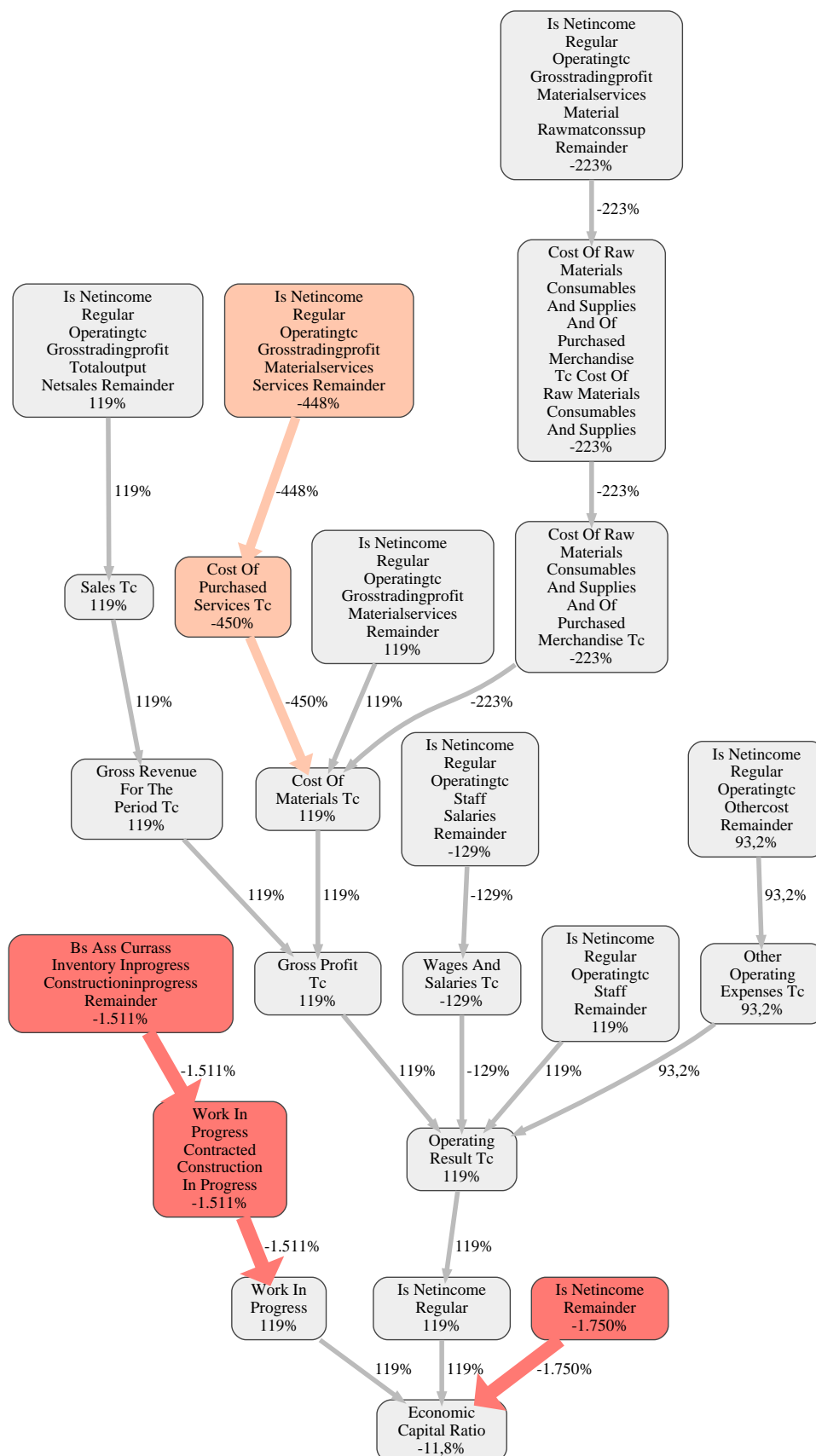

The greatest strength of Otto Mühlherr Baugesellschaft mbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 119% points. The greatest weakness of Otto Mühlherr Baugesellschaft mbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.750% points.

The company's Economic Capital Ratio, given in the ranking table, is 119%, being 12% points below the market average of 130%.
