



The relative strengths and weaknesses of Bauunternehmung Hermann GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Hermann GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 101% points. The greatest weakness of Bauunternehmung Hermann GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 637% points.

The company's Economic Capital Ratio, given in the ranking table, is 101%, being 29% points below the market average of 130%.
