



The relative strengths and weaknesses of Mayerhofer Hoch Tief und Ingenieurbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Mayerhofer Hoch Tief und Ingenieurbau GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 87% points. The greatest weakness of Mayerhofer Hoch Tief und Ingenieurbau GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 1.022% points.

The company's Economic Capital Ratio, given in the ranking table, is 87%, being 43% points below the market average of 130%.
