



The relative strengths and weaknesses of Josef Hebel GmbH Co KG Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Hebel GmbH Co KG Bauunternehmung compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 127% points. The greatest weakness of Josef Hebel GmbH Co KG Bauunternehmung is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 826% points.

The company's Economic Capital Ratio, given in the ranking table, is 127%, being 3,7% points below the market average of 130%.
