



The relative strengths and weaknesses of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 78% points. The greatest weakness of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG is the variable Bs Ass Currass Inventory Inprogress Remainder, reducing the Economic Capital Ratio by 1.069% points.

The company's Economic Capital Ratio, given in the ranking table, is 78%, being 52% points below the market average of 130%.
