



The relative strengths and weaknesses of Helmut Kallage Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Helmut Kallage Bauunternehmen GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 158% points. The greatest weakness of Helmut Kallage Bauunternehmen GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 1.302% points.

The company's Economic Capital Ratio, given in the ranking table, is 158%, being 27% points above the market average of 130%.
