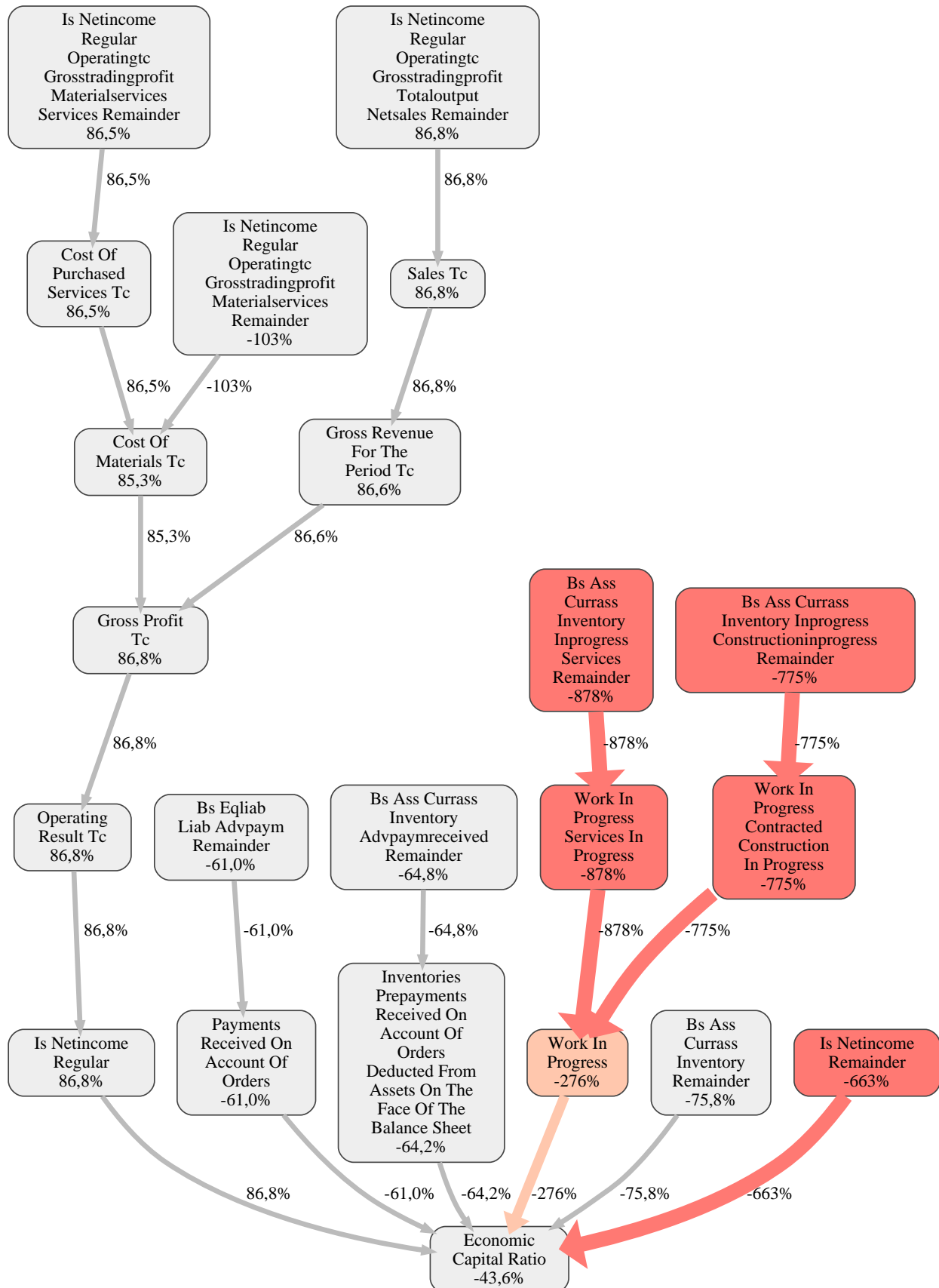

The greatest strength of Bauunternehmung Hofschröder GmbH Co KG compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 87% points. The greatest weakness of Bauunternehmung Hofschröder GmbH Co KG is the variable Bs Ass Currass Inventory Inprogress Services Remainder, reducing the Economic Capital Ratio by 878% points.

The company's Economic Capital Ratio, given in the ranking table, is 87%, being 44% points below the market average of 130%.
