



The relative strengths and weaknesses of Fermo Massivhaus Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fermo Massivhaus Aktiengesellschaft compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 133% points. The greatest weakness of Fermo Massivhaus Aktiengesellschaft is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 905% points.

The company's Economic Capital Ratio, given in the ranking table, is 133%, being 3,0% points above the market average of 130%.
