



The relative strengths and weaknesses of Schrobsdorff Holding AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Holding AG compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 10.193% points. The greatest weakness of Schrobsdorff Holding AG is the variable Bs Ass Fixass Fin Remainder, reducing the Economic Capital Ratio by 9.787% points.

The company's Economic Capital Ratio, given in the ranking table, is 10.463%, being 10.333% points above the market average of 130%.
