



The relative strengths and weaknesses of Angermüller Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Angermüller Bau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Staff Remainder, increasing the Economic Capital Ratio by 148% points. The greatest weakness of Angermüller Bau GmbH is the variable Bs Ass Currass Inventory Inprogress Services Remainder, reducing the Economic Capital Ratio by 1.558% points.

The company's Economic Capital Ratio, given in the ranking table, is 155%, being 25% points above the market average of 130%.
