

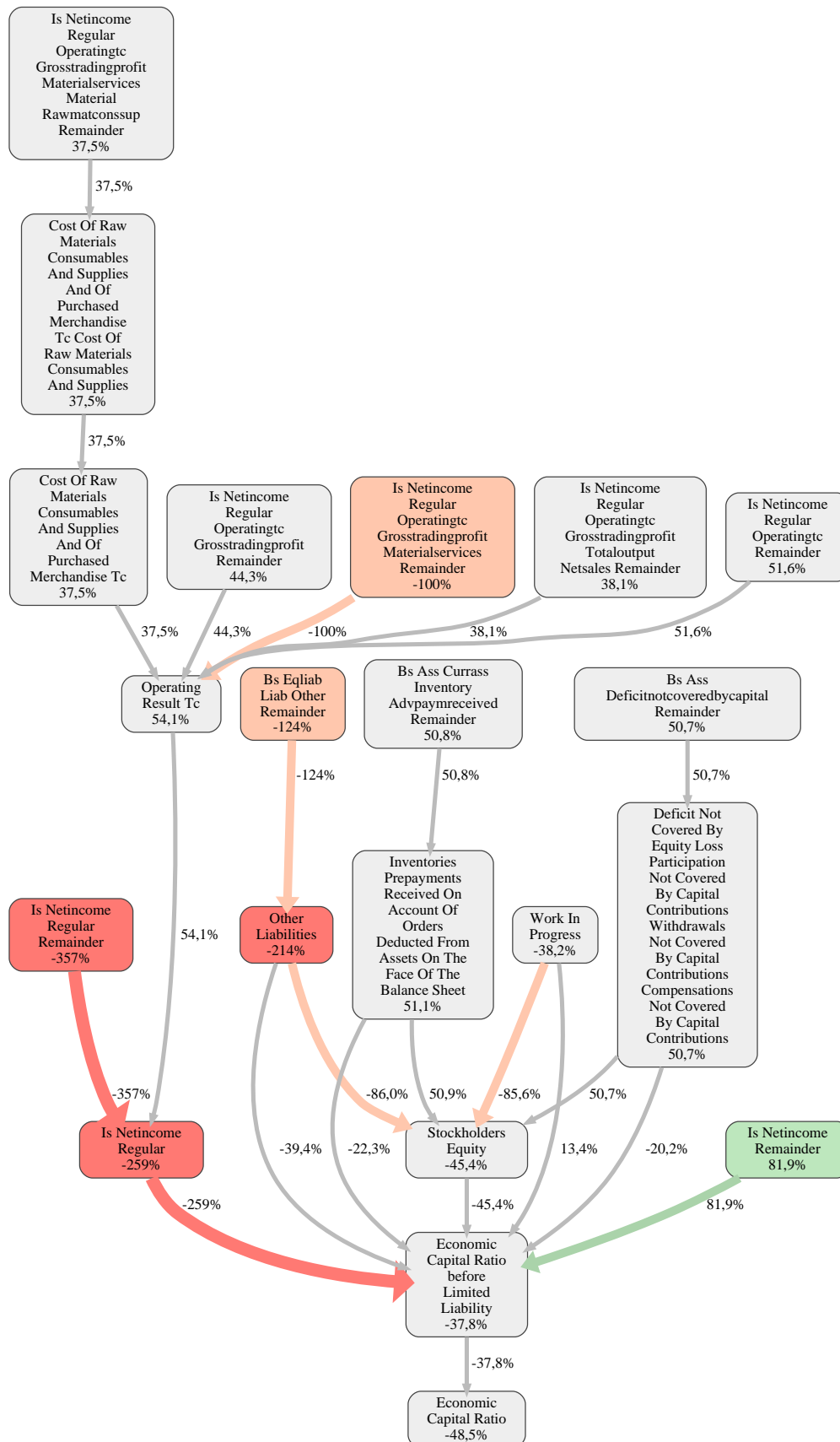

The relative strengths and weaknesses of ZAM Bau Handel und Service GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ZAM Bau Handel und Service GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 82% points. The greatest weakness of ZAM Bau Handel und Service GmbH is the variable Is Netincome Regular Remainder, reducing the Economic Capital Ratio by 357% points.

The company's Economic Capital Ratio, given in the ranking table, is 82%, being 49% points below the market average of 130%.
