

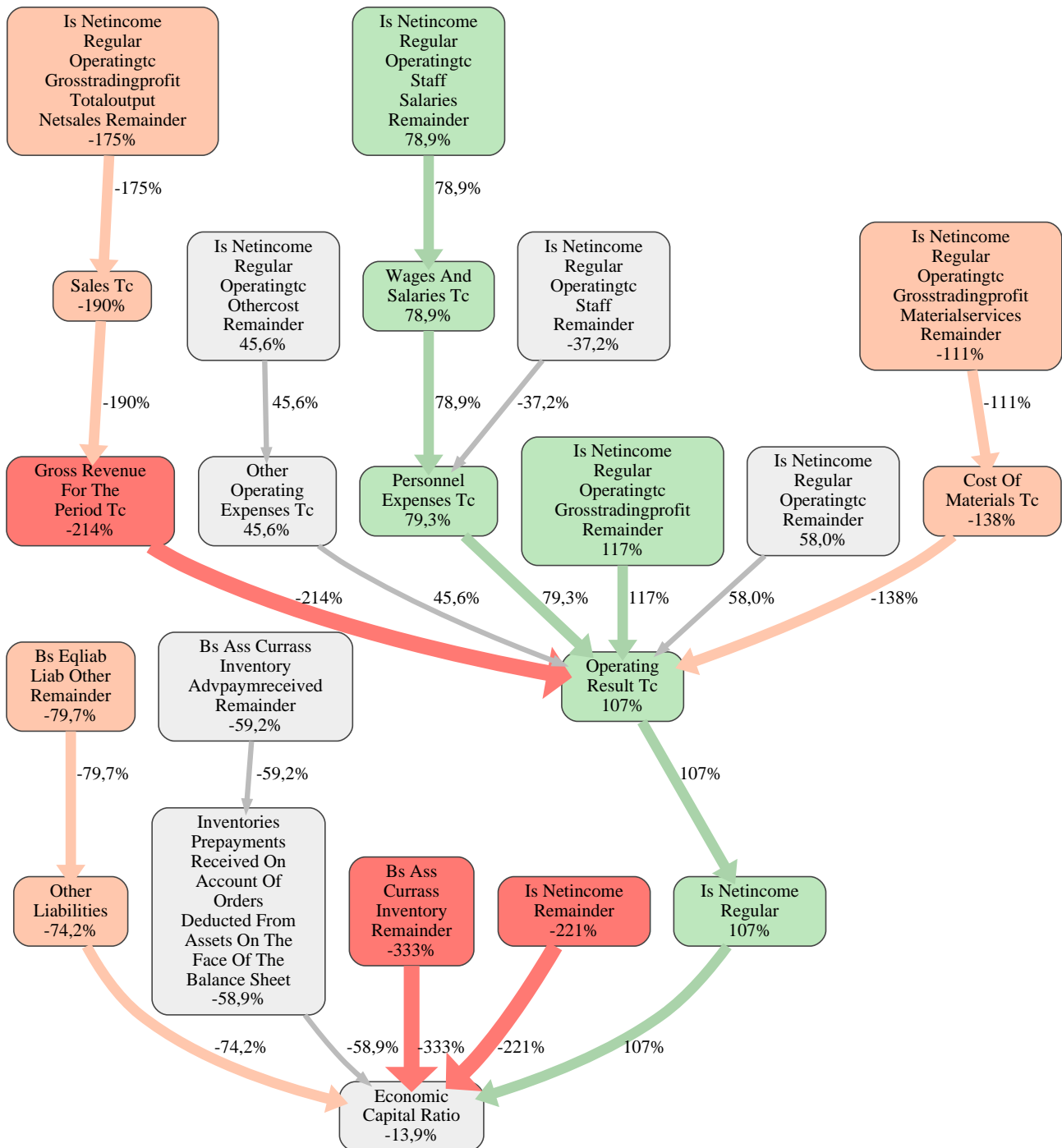

The relative strengths and weaknesses of Laudemann GmbH Bauunternehmen are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Laudemann GmbH Bauunternehmen compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 117% points. The greatest weakness of Laudemann GmbH Bauunternehmen is the variable Bs Ass Currass Inventory Remainder, reducing the Economic Capital Ratio by 333% points.

The company's Economic Capital Ratio, given in the ranking table, is 117%, being 14% points below the market average of 130%.
