



The relative strengths and weaknesses of BAM Corporate Services GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BAM Corporate Services GmbH compared to the market average is the variable Other Operating Income Tc, increasing the Economic Capital Ratio by 151% points. The greatest weakness of BAM Corporate Services GmbH is the variable Bs Eqliab Liab Assoccomp Remainder, reducing the Economic Capital Ratio by 296% points.

The company's Economic Capital Ratio, given in the ranking table, is 210%, being 80% points above the market average of 130%.
