



The relative strengths and weaknesses of Wohnbau Soest GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbau Soest GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 103% points. The greatest weakness of Wohnbau Soest GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 305% points.

The company's Economic Capital Ratio, given in the ranking table, is 103%, being 27% points below the market average of 130%.
