



The relative strengths and weaknesses of Goslarer Wohnstättengesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Goslarer Wohnstättengesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 65% points. The greatest weakness of Goslarer Wohnstättengesellschaft mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 250% points.

The company's Economic Capital Ratio, given in the ranking table, is 65%, being 65% points below the market average of 130%.
