



The relative strengths and weaknesses of Gesobau AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gesobau AG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 60% points. The greatest weakness of Gesobau AG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 255% points.

The company's Economic Capital Ratio, given in the ranking table, is 60%, being 70% points below the market average of 130%.
