

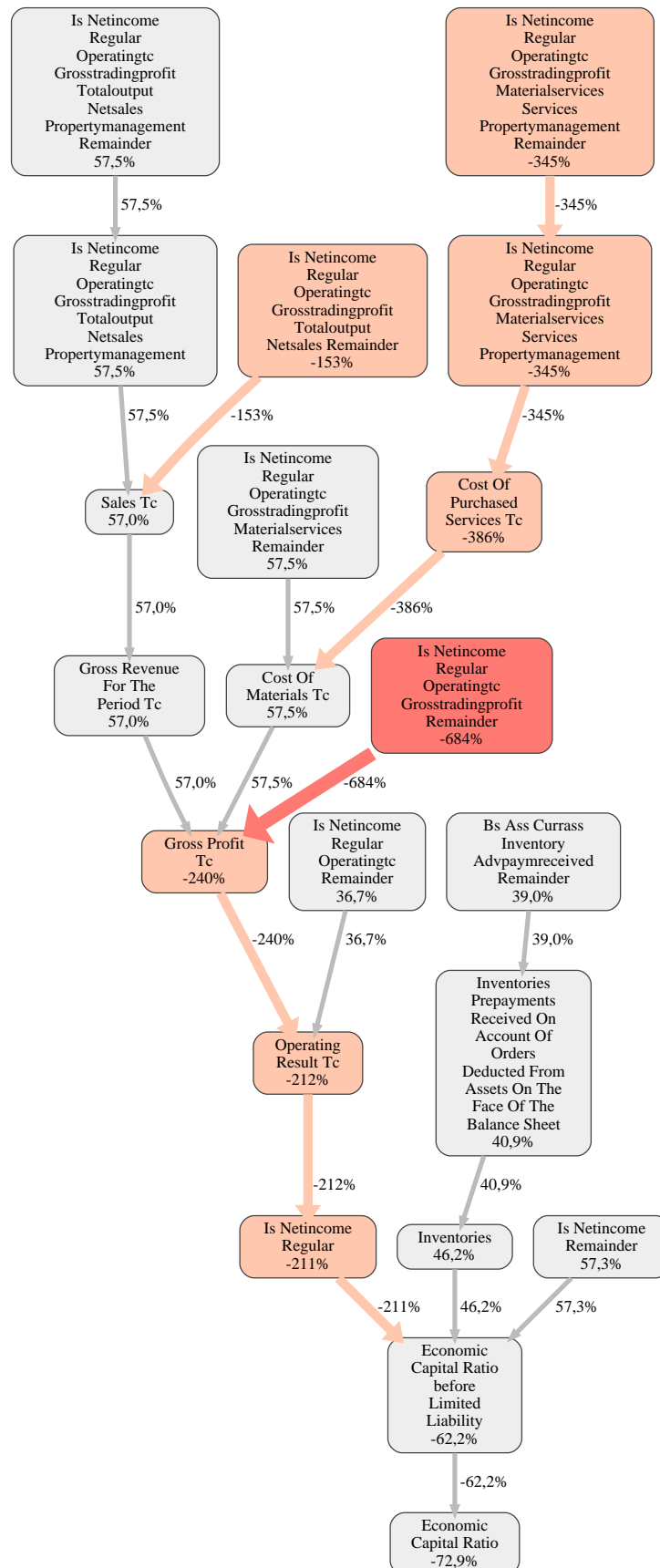

The greatest strength of WBM Immobilien Service GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 58% points. The greatest weakness of WBM Immobilien Service GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 684% points.

The company's Economic Capital Ratio, given in the ranking table, is 58%, being 73% points below the market average of 130%.
