



The relative strengths and weaknesses of Städtische Wohnungsgesellschaft Freiberg Sa Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Städtische Wohnungsgesellschaft Freiberg Sa Aktiengesellschaft compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 74% points. The greatest weakness of Städtische Wohnungsgesellschaft Freiberg Sa Aktiengesellschaft is the variable Operating Result Tc, reducing the Economic Capital Ratio by 236% points.

The company's Economic Capital Ratio, given in the ranking table, is 74%, being 56% points below the market average of 130%.
