

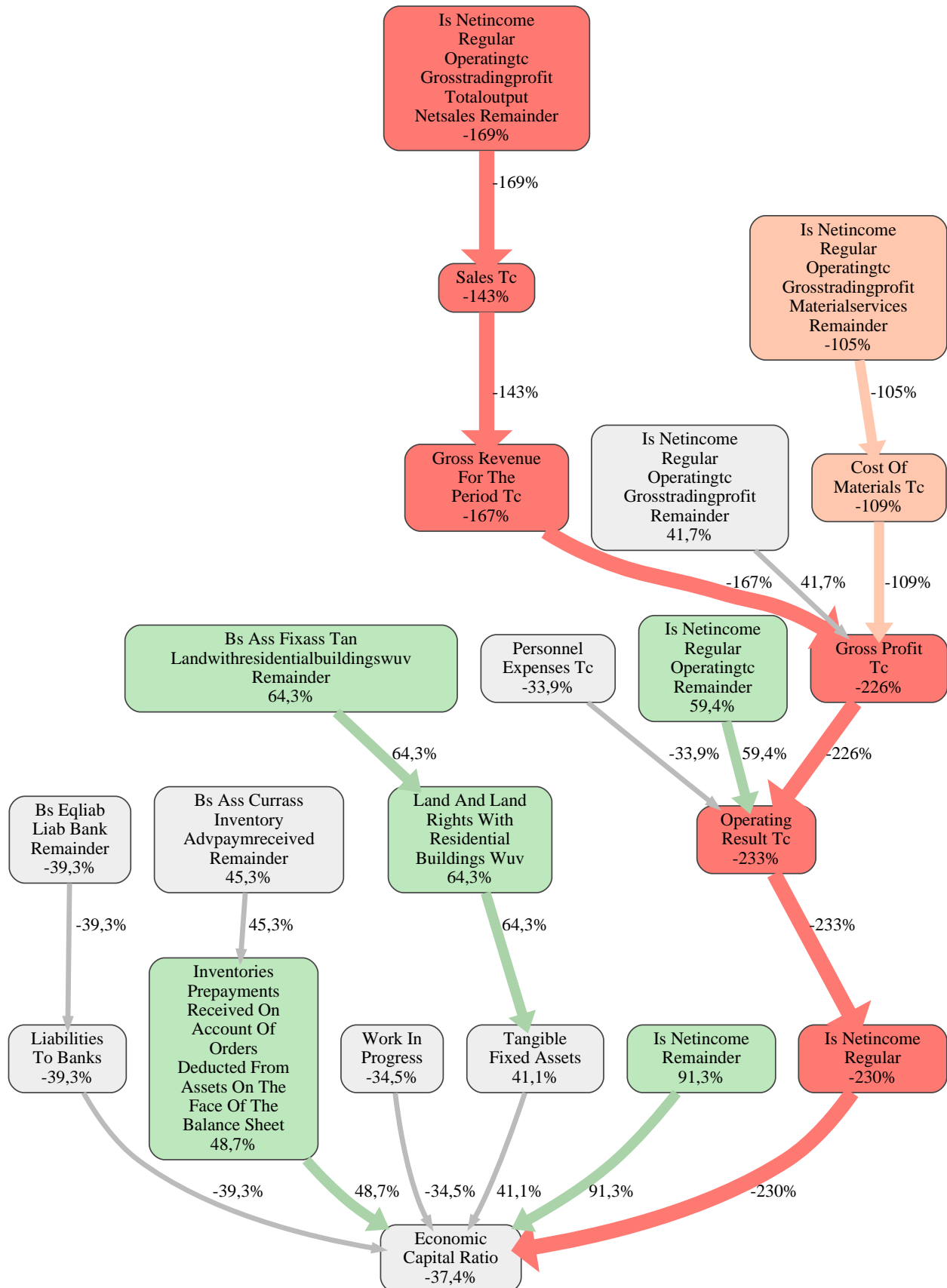

The relative strengths and weaknesses of Wohnungsbau und Verwaltungsgesellschaft mbH Luckau are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Verwaltungsgesellschaft mbH Luckau compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Wohnungsbau und Verwaltungsgesellschaft mbH Luckau is the variable Operating Result Tc, reducing the Economic Capital Ratio by 233% points.

The company's Economic Capital Ratio, given in the ranking table, is 93%, being 37% points below the market average of 130%.
