



The relative strengths and weaknesses of Wohnungsbaugesellschaft Rüdersdorf mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft Rüdersdorf mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 110% points. The greatest weakness of Wohnungsbaugesellschaft Rüdersdorf mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 284% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 19% points below the market average of 130%.
