The greatest strength of Wohnungsbaugesellschaft der Stadt Langenzenn Gesellschaft mit Beschränkter Haftung GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 62% points. The greatest weakness of Wohnungsbaugesellschaft der Stadt Langenzenn Gesellschaft mit Beschränkter Haftung GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 274% points.

The company's Economic Capital Ratio, given in the ranking table, is 62%, being 68% points below the market average of 130%.
