The relative strengths and weaknesses of Wohnungsbau Vermietungs und Verwaltungsgesellschaft mbH Tambach Dietharz are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau Vermietungs und Verwaltungsgesellschaft mbH Tambach Dietharz compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 130% points. The greatest weakness of Wohnungsbau Vermietungs und Verwaltungsgesellschaft mbH Tambach Dietharz is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 226% points.

The company's Economic Capital Ratio, given in the ranking table, is 152%, being 21% points above the market average of 130%.
